

**THE CORPORATION OF THE
TOWNSHIP OF LANARK HIGHLANDS**

BY-LAW NO. 2015-1313

A BY-LAW TO AMEND BY-LAW 2012-1205 (PROCEDURAL BY-LAW)

WHEREAS Council has enacted By-law 2012-1205 being a by-law to establish the rules governing the order and proceedings of Council and Committees of the Corporation of the Township of Lanark Highlands;

AND WHEREAS Council deems it expedient to further amend By-law 2012-1205 with respect to the time and exceptions in which Council and the Committee of the Whole meetings are held;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF LANARK HIGHLANDS HEREBY ENACTS AS FOLLOWS:

- 1. THAT** Section 5.2.1 of By-law 2012-1205 entitled Council Meetings be deleted and replaced as follows:

"Township council meetings shall generally be held in the Council chambers at the Lanark Highlands Municipal Office, 75 George Street, Lanark, immediately following the Committee of the Whole meetings, as outlined in the Meeting Schedule."

- 2. THAT** Section 5.3.1 of By-law 2012-1205 entitled Committee of the Whole be deleted and replaced as follows.

"Committee of the Whole meetings shall generally be held in the council chambers at the Lanark Highlands Municipal Office, 75 George Street, Lanark, commencing at 6:00 p.m. as outlined in the Meeting Schedule."

- 3. THAT** Section 5.13.3 of By-law 2012-1205 which states that regular Council meetings are to be held once a month, be deleted and replaced as follows;


"Regular Council Meetings are generally held twice a month except during the month that has been declared the "Summer Recess" and as otherwise outlined in the Meeting Schedule."

4. **THAT** Section 7.3.2 of By-law 2012-1205 under Adjournment which states that all Committee meetings shall adjourn no later than 5:30 p.m., unless a motion to proceed beyond 5:30 p.m. is approved, be deleted and replaced as follows;


"All Committee meetings shall adjourn no later than 8:30 p.m., unless a motion to proceed beyond 8:30 pm is approved."

5. **THAT** this By-law shall come into full force and effect on the date of final passage hereof at which time all By-laws that are inconsistent with the provisions of this By-law and the same are hereby repealed insofar as it is necessary to give effect to the provisions of this By-law.

THIS BY-LAW read a first, second and third time and passed by the Council for the Township of Lanark Highlands this **13th day of January, 2015.**
