BY-LAW NO. 2018-1536

BEING A BY-LAW TO APPOINT A COMMITTEE OF ADJUSTMENT

WHEREAS Section 44 of the *Planning Act, R.S.O. 1990, Chapter P.13, as amended*, provides that the Council of the municipality may by by-law constitute and appoint a committee of adjustment for the municipality if a municipality has passed a by-law under Section 34;

AND WHEREAS the Council of the Corporation of the Township of Lanark Highlands has passed a by-law under Section 34 of the *Planning Act, R.S.O. 1990, Chapter P.13, as amended* (zoning by-law);

AND WHEREAS Section 44(3) of the *Planning Act, R.S.O. 1990, Chapter P.13, as amended*, provides that the members of the committee who are members of a municipal council shall be appointed annually;

AND WHEREAS the Council of the Corporation of the Township of Lanark Highlands deems it expedient to constitute and appoint a Committee of Adjustment;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Township of Lanark Highlands enacts as follows:

1. GENERAL REGULATIONS

1.1 THAT the Committee of Adjustment for the Corporation of the Township of Lanark Highlands is hereby constituted and the following persons are hereby appointed as its members for the term ending December 31st, 2019, or until their successors are appointed;

- ii) John Hall
- iii) Ron Closs
- iv) Steve Roberts
- v) Peter Rodger
- vi) Jeannie Kelso
- vii) Bill King

- 1.2 **THAT** the duties and powers of the Committee of Adjustment shall be as laid out under Section 45 of the *Planning Act, R.S.O. 1990, Chapter P.13, as amended*;
- 1.3 **THAT** the Secretary-Treasurer of the Committee of Adjustment shall be the Deputy Clerk/Planning Administrator of the Corporation of the Township of Lanark Highlands;

2. BY-LAWS TO BE RESCINDED

THAT By-Law No. 2017-1466 is hereby rescinded;


3. ULTRA VIRES

Should any sections of this by-law be declared by a court of competent jurisdiction to be ultra vires, the remaining sections shall nevertheless remain valid and binding.


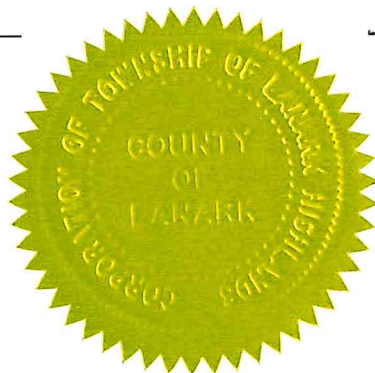
4. EFFECTIVE DATE
