TAKE NOTICE THAT the Committee of Adjustment of the Township of Lanark Highlands will hold a Public Meeting on **September 26, 2017 at 6:00 p.m.** in the Council Chambers, 75 George St. Lanark, Ontario to hear an application for minor variance under authority of Section 45 of the *Planning Act*.

PURPOSE AND EFFECT:

To seek permission to demolish an existing cottage and erect a new residence in the Rural Zone (RU) Zone and Limited Services Rural Zone (LSR) Zone (Section 6.0 and 10.0 Zoning By-law 2003-451) with a reduced front yard setback from the waterfront of (24.3m). A key map showing the location of the subject lands is shown on the reverse side.

NOTICE OF DECISION - A certified copy of the decision, together with a notice of the last day for appealing to the Ontario Municipal Board shall be sent, not later than 10 days from the making of the decision, to the applicant, and to each person who filed with the secretary-treasurer a written request for notice of the decision.

ADDITIONAL INFORMATION - information regarding the application will be available for public inspection on at the Township of Lanark Highlands Municipal Office by appointment during regular business hours, Monday to Friday, from 8:30 a.m. to 4:30 p.m.

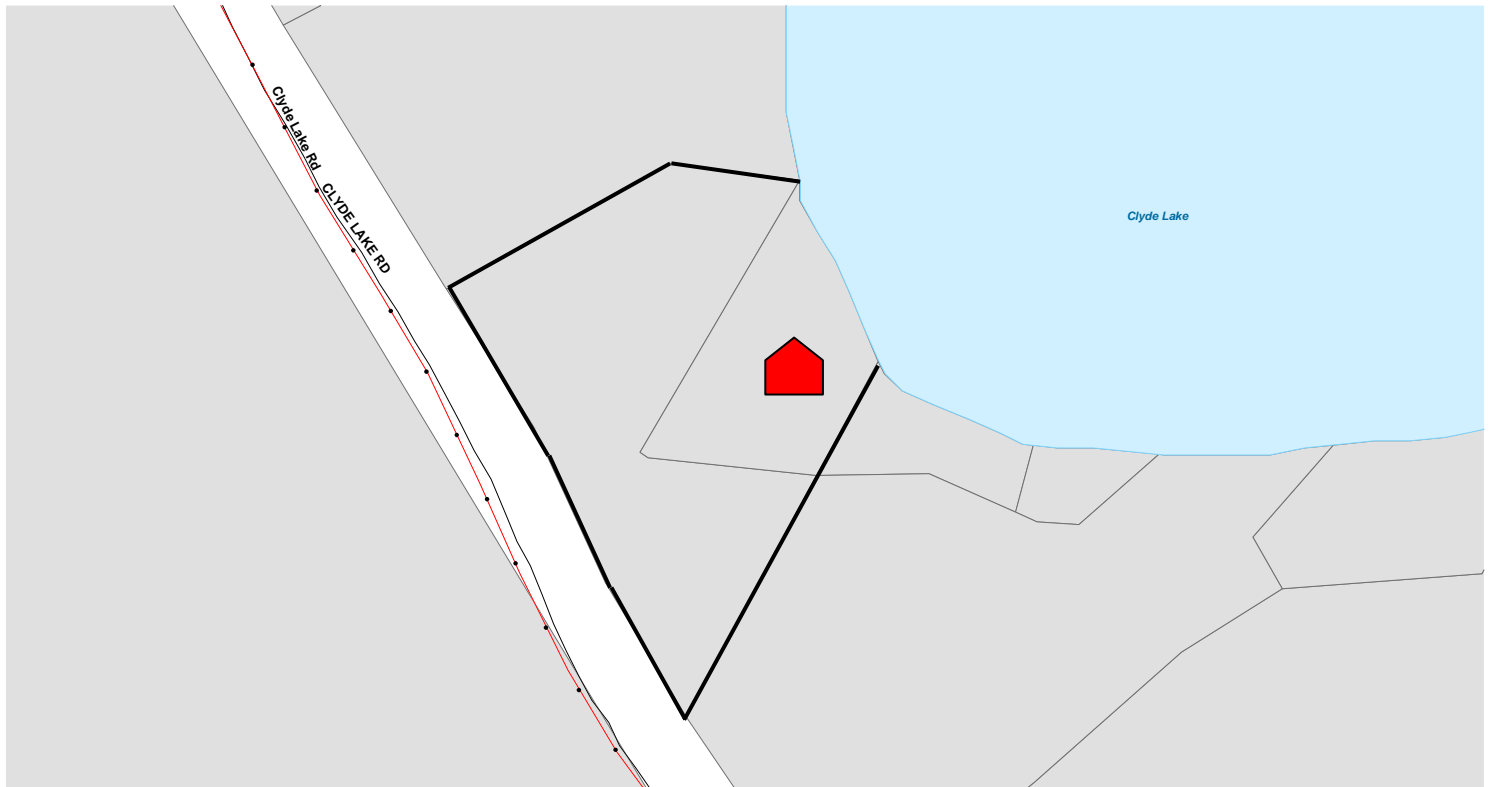
