TAKE NOTICE THAT the Committee of Adjustment of the Township of Lanark Highlands will hold a Public Meeting on **August 29, 2017** at **6:00 p.m.** in the Council Chambers, 75 George St. Lanark, Ontario to hear an application for minor variance under authority of Section 45 of the *Planning Act*.

PURPOSE AND EFFECT:

To seek permission to construct an addition to a single family dwelling in the Limited Service Rural (LSR) zone (Section 10.0 Zoning By-law 2003-451) with a reduced side yard setback from the waterfront of 24m. A key map showing the location of the subject lands is shown on the reverse side and a copy of the application is attached.

PUBLIC HEARING - You are entitled to attend this public hearing in person, or you may be represented by counsel or an agent to provide information, to comment, or to ask questions about this application. FAILURE TO ATTEND HEARING - If you do not attend this public hearing, it may proceed in your absence and, except as otherwise provided in the *Planning Act*, you will not be entitled to any further notice in the proceedings.

NOTICE OF DECISION - A certified copy of the decision, together with a notice of the last day for appealing to the Ontario Municipal Board shall be sent, not later than 10 days from the making of the decision, to the applicant, and to each person who filed with the secretary-treasurer a written request for notice of the decision.

ADDITIONAL INFORMATION - information regarding the application will be available for public inspection on at the Township of Lanark Highlands Municipal Office by appointment during regular business hours, Monday to Friday, from 8:30 a.m. to 4:30 p.m.

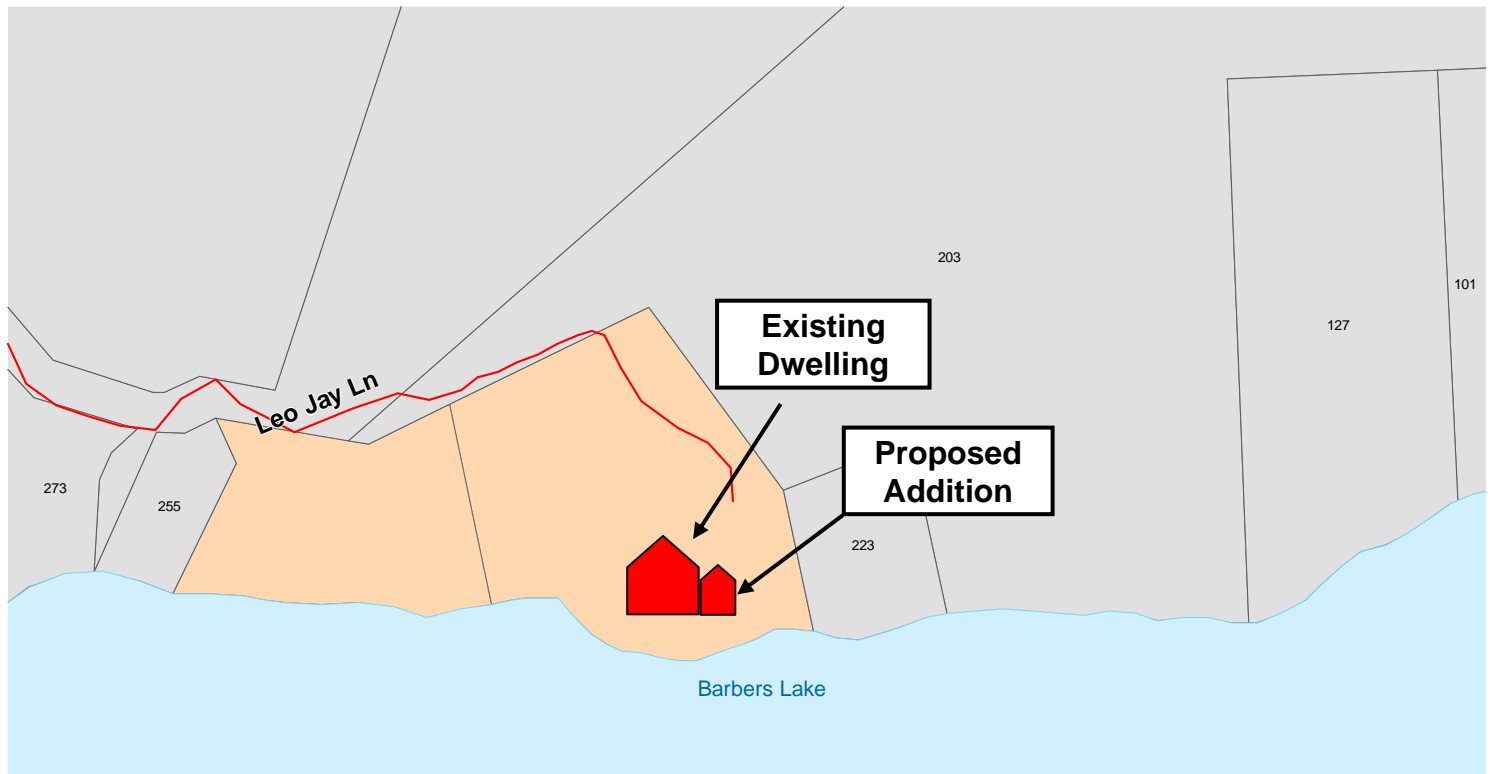
