# THE CORPORATION OF THE TOWNSHIP OF LANARK HIGHLANDS

### BY-LAW NO. 2022-1780

## TO REPEAL AND REPLACE BY-LAW 2022-1766 AND TO SET THE TAX RATES FOR THE YEAR 2022

**WHEREAS**, Section 312 of the *Municipal Act*, 2001, S.O. 2001, c. 25, as amended, provides that the Council of a local municipality shall, after the adoption of estimates for the year, pass a by-law levying a separate tax rate on the assessment in each property class;

**AND WHEREAS**, the Council of the Corporation of the Township of Lanark Highlands has adopted a budget, including estimates of all sums required during the year for the purposes of the municipality, in accordance with Section 290 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended;

**AND WHEREAS** Section 312 (6) of the said Act requires tax rates to be established in the same proportion to the tax ratios;

AND WHEREAS, the Council of the Corporation of the County of Lanark has adopted By-Law 2022-14, being a by-law to set tax ratios and to set tax rate reductions;

AND WHEREAS, the Council of the Corporation of the County of Lanark has adopted By-Law 2022-15, being a by-law to set tax rates for upper tier purposes;

AND WHEREAS, the Province of Ontario has regulated all education tax rates for 2022.

**NOW THEREFORE BE IT RESOLVED THAT**, the Council of the Corporation of the Township of Lanark Highlands enacts as follows:

#### 1. GENERAL REGULATIONS

- 1.1 THAT By-law No. 2022-1766 be herby rescinded;
- 1.2 THAT for the year 2022, the tax rates to be applied to the taxable assessment of the Township of Lanark Highlands be as set out in Schedule "A", attached hereto;

#### 2. ULTRA VIRES

2.1 Should any sections of this by-law, including any section or part of any schedules attached hereto, be declared by a court of competent jurisdiction to be ultra vires, the remaining sections shall nevertheless remain valid and binding.

- 3.1 This By-Law shall come into force and effect on the day of its passing.
