Notification and Consultation under the Aggregate Resources Act

Thomas Cavanagh Construction Limited (Cavanagh) has applied to the Ministry of Natural Resources and Forestry under the Aggregate Resources Act (ARA) for a Class A Licence to permit a below water pit in the Township of Lanark Highlands.

The proposed pit is located on Highland Line across from the McKinnon Pit approximately 2 km west of Concession Road 9A.

The proposed pit would have a licensed area of 50.6 hectares (125 acres) and extraction area of 35.1 hectares (86.7 acres). Extraction would occur above and below the groundwater table.

In conjunction with the Licence application under the Aggregate Resources Act, Cavanagh submitted applications to amend the County's Official Plan and Township's Official Plan and Zoning By-law. These applications were deemed complete by the County and Township on February 16, 2023 and January 30, 2023, respectively.

The purpose of this letter is to advise the County and Township that Cavanagh is initiating the Notification and Consultation Stage under the ARA application process. In accordance with the

provisions of the ARA, please find enclosed the Public Notice of Application Form. Any comments on the application must be submitted to both Cavanagh and MNRF by **June 5, 2023.**

A public information session will be held on April 27, 2023 at the Lanark & District Civitan Club from 6 to 8 pm to provide information to the public and answer questions related to the application.

As required by the Aggregate Resources Act, Cavanagh must send the ARA Application including the site plan and all technical reports to the County and Township. A digital copy of these application materials can be downloaded from the project website: http://cavanagharaapprovals.com

Following submission of the ARA Application, we became aware that the recommendations from the Water Report were inadvertently missing from the ARA Site Plan. These recommendations have now been incorporated on the Site Plan and the correct version is included on the project website noted above. The correct version will also be circulated to the other review agencies and landowners.

Apart from this change, the application materials included with the ARA Application are the same as those submitted with the planning applications with the following additions:

- 1. ARA Licence Application Form
- 2. Ministry checklists for evaluating archaeological and heritage potential
